Competitor: 8. AF Corse

Facts Car #8 caused a collision

Offence: Breach of Int GT Open Sporting Regulations Art. 15.1.d and Art. 19.3 and Art 2.b Chapter IV App L ISC

Penalty: TEN seconds time penalty, to be added to the total elapsed time by the competitor

Reason: Driver #8 drove in a manner which caused him to collide with #16, therefore he is wholly or predominantly to blame for the incident.
