10.3 Clean Pit Boxes and paddock

Teams have to leave the pit boxes and paddock clean, in the same state as when they entered the property. Please understand that any cost of cleaning circuit-properties, provoked by the competitor, driver or any team member will be accounted to the competitor.

10.4 Intervention break rules

However, according the regulations, for class 991 teams, the 991-PRO-BOP and 991-AM-BOP is still applicable For the class 991 BOP- table, see the applicable BOP-publication.

10.6.3 Neutralizing the Race by the use of the Safety Car.

- With respect to the use of the Safety Car, the race director shall have overriding authority and the Clerk of the Course may give orders in respect thereof only with his express agreement.
- The car will be marked as "SAFETY CAR". It will be fitted with revolving lights, yellow and green. It will be driven by an experienced circuit driver who will be in permanent radio contact with Race Control.
- When the Clerk of the Course gives the order to deploy the Safety Car, all signalling posts will display waved yellow flags and a white "SC" board with black letters. This signalling will be kept until the Safety Car finishes its intervention and leaves the track.
- The Safety Car will join the track from the Pit Lane exit with the revolving yellow lights on, regardless of the position of the race leader.
- All the competing cars will form up in line behind the Safety Car no more than 5 car lengths apart. All overtaking on the track is forbidden (except under starting procedure) unless a car is signalled to do so from the Safety Car.
- The Safety Car shall be used at least until all cars are lined up behind him, keeping the formation as tight as possible.
- While the Safety Car is in operation, competing cars may enter the Pit Lane but may only rejoin the track when the green light at the pit exit is on. The light will be red at all times except when the Safety Car and the line of









cars following it have passed the pit exit. At that moment the green light will be on for a short period of time. A car rejoining the track under these conditions will proceed at reduced speed, without overtaking, until it reaches the end of the line of cars behind the Safety Car.

- When the Clerk of the Course calls in the Safety Car (end of the neutralization), it will turn the flashing lights off, thus indicating the drivers that it will be entering the Pit Lane at the end of the current lap. From that moment, the first vehicle behind the Safety Car will set the pace and if the driver considers it necessary, he will be able to follow the Safety Car more than five car lengths apart. In order to avoid any accident before the Safety Car returns to Pit Lane, and from the moment the flashing lights are off, drivers will have to keep a steady and constant pace, avoiding any acceleration, hard braking or changes of direction in a brusque and unexpected way, as well as any manoeuvre that may imply danger for the rest of the drivers or impede the resumption of the race.
- When the Safety Car is close to the Pit Lane entrance the yellow flags and the "SC" boards will be withdrawn from all signalling posts and replaced by waved green flags, while green lights will be shown on the start-finish line. The green flags will be shown during one lap. Overtaking remains strictly forbidden until the cars have crossed the timing Line.
- During the Safety Car procedure, from approximately 150 metres before the timing line, up to the line itself and during the whole neutralisation process, the drivers will be obliged to pass in line and spaced out in front of the said timing line.
- Each lap completed while the Safety Car is in service will be counted as a race lap.
- If during this procedure the time should reach 12.00 a.m. on Sunday, the Safety Car will take the chequered flag and all vehicles capable of doing so must follow it to the Parc Fermé.

12. Entry: Closing Date and Acceptance

13. Collection of Documents/Administrative Control

The competitor and the driver, or their officially nominated representative must be present at the place and time indicated for the administrative/license-control and scrutineering.

At the license control the competitor will receive the scrutineering forms (control card).

The driver/competitor must sign the 'responsibility clause' (according to the General regulations concerning racing contests).

After the team has completed the control card, they will receive a so called "FINAL APPROVED" sticker of the specific race.

Only this final sticker (as provided by the Secretary of the Event) indicates that the car/competitor is allowed to participate. Without this "FINAL APPROVED" sticker, the car may not participate in any practices, qualifying and the race.

21. Fuel and Refuelling

See Chapter I, art. 21.3 of the Sporting & Technical Regulations. The opening times of the pumps will be published on the official time schedule. There will be 6 Petrol pumps and 1 Diesel pump(s). **All instructions of fuel station personnel, pit- and or fire marshals have to be followed strictly.**

22. Tickets/Passes/Paddock

Every person (drivers, team members, officials, press etc.) who enters the pit area must at all times wear his ticket/pass visible, in a way that the controlling officials can at any time without problem see whether this person has the right ticket/pass. If a person is not wearing his ticket/pass visible, he may not enter the pit area. Paddock space per box (included in the entry fee) according to the plan attached.









23. Timekeeping

23.1 Transponder

Every car must be equipped with a ID-transponder. See art. 5.2 Chapter II of the Sporting & Technical regulations. Fraud or obstruction of the rules mentioned in this article will be sanctioned by the Race Director.








Esquema 2: Paddock y Boxes
