- The entry form must be signed by the Team Manager and all riders. In case that the team has a second team manager it will be necessary to request authorisation to the Organiser.
- It is necessary to attach to the form the bank receipt and the technical document of the motorbike.
- It is necessary to attach to the original entry form one photo of the Team Manager and riders. Also, you can send them by e-mail (.jpg format) or by post (with the names written behind).
- During the Sporting Checks, the Team Manager shall present the original licences of the riders. If previously he/she has not presented to the Organisation the passports and photos, he/she must do in that moment.
- Forms will not be accepted unless correctly completed.
- Race numbers will be assigned at the discretion of the Organisation. Any number will not be confirmed until the entry period closes. The teams can request some numbers in sections "Comments". Numbers with 3 digits are not accepted.
